# Mountain Discovery Charter School 1:1 Chromebook Initiative Student/Parent Agreement

## **Program Mission:**

The mission of the MDCS 1:1 initiative (one electronic device for each middle school student) is to ensure that Mountain Discovery students in grades 4 - 8 have regular, equitable access to the digital tools and resources that allow them to be successful 21<sup>st</sup> century learners. To reach this goal, the school will provide students with digital devices that can expand their learning opportunities beyond the walls of Mountain Discovery Charter School.

## **Description:**

Mountain Discovery has adopted a 1:1 Chromebook program in our middle school, which will provide an electronic device (i.e., Chromebook) to each student for his/her use during the school day. These devices will be issued to students at the beginning of the school year.

#### **Costs:**

- There is no cost to receive the device.
- Damage to a device that is beyond repair will result in responsibility for a full replacement of the device. The replacement cost for a lost or damaged Chromebook 1-2 years old is \$305, 3-4 years old is \$229, and 5 years or older is \$199. The replacement cost for a lost or damaged charging cord is \$35.00.
- Lost, stolen or questionable damage will be reviewed by the administration on a case-by-case basis to determine fees.
- Students with damaged equipment will not be issued a replacement device until the replacement fee has been received.

#### Be Responsible:

- No stickers or writing allowed on the device.
- Students must take measures to protect the device from damage or theft.
- At no time shall the device be used for unlawful or inappropriate activities.
- Students are not allowed to let others use their assigned device.
- Students will only use the MDCS devices for academic purposes.

#### Be respectful:

Students must follow the Mountain Discovery Charter School Acceptable Use and Internet Safety Procedures at all times while using school-issued devices.

Violators of the Acceptable Use Policy or items stated in this document will be addressed by the school administration to determine the proper course of action.

No right of privacy exists in the use of devices provided by the school.
